Statewide

The state legislature should not usurp the governor's emergency powers! Please therefore vote "No" and "No" on the Emergency Declarations Amendments (PA Question 1 and PA Question 2). We endorse "Yes" on the Equal Rights initiative /PA Question 3 (proposed by Vincent Hughes).

Maria McLaughlin receives our endorsement for the Pennsylania Supreme Court. In a contested primary, Jill Beck's superior answers won her our endorsement for Pennsylvania Superior Court. For Commonwealth Court, we received excellent answers from two old and trusted friends, and thus happily endorse Amanda Green Hawkins and David Spurgeon.

Allegheny County

Never have we seen nine seats open on **Allegheny County's Court of**

Common Pleas—nor so many excellent candidates. With much discussion and some regret (good candidate who did not submit responses; past endorsees and worthy contenders whose answers didn't make the cut) we reached agreement on eight. In ballot order:

Lisa Middleman (you will remember her as a recent, excellent, reformminded candidate for DA). Chelsa Wagner (our eagle-eyed County Controller since 2012). Nicola Henry-Taylor (who makes equity and inclusion cornerstones of her campaign). Brian Malkin (his contracts and numbers, computer-sci and ecology background fills a hole on the court-and does not obscure his egalitarian heart). Mik Pappas (as a magistrate, he reduced evictions 40% by leveraging social service support and mediation). Giuseppe Rosselli (who brings a similar focus on putting in the extra effort needed to help people help themselves out of life's holes). Patrick Sweeney (who talks the talk-his answers for us were excellent-and he 100% walks the walk. Sabrina Korbel (bringing her experience as Legal Director for the Women's Center and Shelter of Pittsburgh and training on how trauma affects testimony). All have grappled with the sad fact that "justice" has not

always been justly applied. For the ninth slot, use another group's list, your own research, or leave blank.

For Allegheny County Council, 9th District: Good-natured, "can-do" educator Steven Singer gets a gold star (and our endorsement.)

Please vote "Yes" on the Allegheny County Initiative to Prohibit Solitary Confinement in the county jail (except emergencies, lockdowns and protective separation).
